PETER MILLAR PRIZE DRAW (the “Prize Draw”) begins on 14th November 2024 at 00:01 GMT and ends on 14th December 2024 23:59 GMT (the “Prize Draw Period”).

- 1. Sponsor:** Peter Millar UK Limited, whose registered office is at 15 Hill Street, London, W1J 5QT.
- 2. Eligibility:** This Prize Draw is open to individuals who at the time of entry **[1]** are at least 18 years of age or the age of majority in their state, province or country of residence, **[2]** possess the legal capacity to enter into contract, **[3]** are considered to be a new subscriber of the Sponsor’s marketing, meaning that the individuals have not previously subscribed to receive marketing information about the Sponsor’s products or services, **[4]** have a valid email account, and **[5]** reside in the United Kingdom, or in the following countries: Austria, Belgium, Bosnia and Herzegovina, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, North Macedonia, Monaco, Montenegro, Netherlands, Norway, Poland, Portugal, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland (“**you**” or “**Entrant**”). Employees, officers, directors and agents of Sponsor, their associated companies, professional advisors, advertising and promotions agencies, as well as members of such employees’ and agents’ immediate families (spouses, and parents, children and siblings and their respective spouses, regardless of where they reside) and individuals living in the same household with such employees and agents, whether or not related, are not eligible to win. The Prize Draw is subject to all applicable national, federal, state, provincial and local laws, rules and regulations. Sponsor, in its sole discretion, may accept a mistyped Entry. You understand and agree that, if you provide a mobile phone number in your Entry, you may incur charges specified in your wireless carrier’s rate plan. The Winner shall win an E-Gift Card worth £500.00 (five hundred pounds GBP) to use for a shopping experience on www.petermillar.co.uk (the **Website**). The Winner shall receive an electronic E-Gift Card from the Sponsor to select products worth up to £500.00 (five hundred pounds GBP) of their choosing from the Website. Any selected products which amount to over £500.00 (five hundred pounds GBP) shall be paid for by the Winner at their own cost. All delivery costs are paid by the Sponsor. The same delivery address must be used for all orders placed. The Winner shall have twelve (12) months to spend the E-Gift Card worth £500.00 (five hundred pounds GBP) from receiving notification from the Sponsor that they have won. Any remaining balance left on the E-Gift Card after twelve (12) months will be removed and the card will be invalid and no longer available for use. The prize is non-transferable and there is no cash alternative. There will be no cash redemption through refunds made. 5. **Determination of the Winner:** The Winner will be chosen by random draw performed by a computer process on 15th December 2024, from all eligible entries received during the Prize Draw Period. The potential winner of the Prize Draw will be contacted via message to Entrant's email address within five working (5) days of the random drawing. The potential winner must respond to the Sponsor within five working (5) days of receiving the notification via email in order to claim the Prize and communicate their name, postal address, telephone number and winning code that was sent in the email from the Sponsor. Once the potential winner responds to the Sponsor's notification, they are confirmed as the ("**Winner**"). It is your sole responsibility as Winner to notify the Sponsor in writing if you change your email address and/or any of your contact details.
